ORDER

Following disposition of this appeal on April 18, 2017, a judge of the Court requested a poll on whether to rehear the case *en banc*. A poll having been conducted and a majority of the active judges of the Court having voted in favor of rehearing this appeal *en banc*, IT IS HEREBY ORDERED that this appeal be heard *en banc*. See Fed. R. App. P.

35(a). The *en banc* panel will consist of the active judges of the Court, as well as those senior judges who sat on the panel that heard the initial appeal. See 28 U.S.C. § 46(c).

The parties are instructed to brief only the following question: "Does *Title VII of the Civil Rights Act of 1964* prohibit discrimination on the basis of sexual orientation through its prohibition of discrimination because of . . . sex'?"

We invite amicus curiae briefs from interested parties. Appellants' brief and appendix, and any amicus curiae briefs in support thereof, shall be filed by June 26, 2017. Appellees' brief and appendix, and any amicus curiae briefs in support thereof, shall be filed by July 26, 2017. Appellants' reply brief shall be filed [*7] by August 9, 2017.

Oral argument will be held on September 26, 2017 at 2:00 p.m. at the Thurgood Marshall United States Courthouse, 40 Foley Square, New York, NY.
